2012 ILLINOIS COUNTY FAIRS GENERAL CONDITIONS

ENTRIES: Two days (a 48-hour box) in effect for all county fairs hosting Illinois Conceived and Foaled Thoroughbred and Quarter Horse Races unless otherwise noted. Entries will close at 10:00 a.m. two days prior, unless otherwise noted, to the scheduled date of the race. **Each horse's Illinois-Registration number must be provided at the time of entry.**

NEGATIVE COGGINS TEST: According to Illinois law, all horses are required to have proof of a negative Coggins test for EIA performed within the last twelve months.

OPEN RACES: Please contact the Racing Secretary for additional requirements and/or fees.

THOROUGHBRED SECTION

As a courtesy to the Illinois County Fair Thoroughbred Association (I.C.F.T.A.), the following information is offered.

I.C.F.T.A. REGULATIONS

Regulations for conducting races:

1. Only fairs that have paid I.C.F.T.A. dues are eligible for the incentive awards. (Jockey & Owner)
2. An administrative/maintenance fee is collected on Illinois-bred state paid purses.
3. Illinois-bred races to have entries from three (3) different owners and three (3) to start, or race is not conducted. Please try to have as many as possible. Any horse that is scratched, which would cause the race not to run, will **NOT** get their administrative fee returned, but the rest of them will.
4. If a horse is entered and programmed, then is scratched, the administrative fee is **NOT** returned. But if the race or races are canceled due to weather just before or after the races have started, \$10.00 of the fee will be retained by the fairs and the remaining \$15.00 will be returned to the owner.
5. Jockey fees are collected and paid out to them for riding, **BUT** if a horse is scratched or not enough riders, the jockey's fee is returned to the owner of the horse.
6. The Racing Secretary of the fair association is the only person authorized to receive entries and declarations.
7. All entries must be made in writing on Official Entry blanks furnished by the fair association and all requested information must be furnished at the time of entry. Entries may be made by telephone, if promptly confirmed by the Racing Secretary and will be valid or recognized, if the name of the horse so entered has been printed on the "official program".
8. All entries will be closed at the advertised time.
9. At the closing time for filing entries for the succeeding day, the horses entered shall be drawn by lots for post positions and a typewritten list of the horses drawn will immediately be posted on the bulletin board in the Racing Secretary's office for inspection by the owners and trainers.
10. The entries of the races for the succeeding day shall become "Official" thirty minutes after such posting and no changes thereafter shall be made because of any omissions or inaccuracies.
11. All horses must be stabled on the fairgrounds no later than two (2) hours prior to the post time for the first race of the day.
12. Jockeys must wear protective helmets and vests.

THOROUGHBRED SECTION

I.C.F.T.A. REGULATIONS *continued*

13. No jockey shall be permitted to ride who is presently under suspension or ruled off in the State of Illinois or in any other State.
14. The jockeys must be attired in racing silks.
15. No whips or spurs permitted in two-year old races.
16. The track shall be in suitable condition for thoroughbred racing as determined by the Racing Secretary.
17. A mechanical starting gate shall be used at the start of all races and a horse shall not be considered a starter unless he leaves the starting gate with the field.
18. Sufficient time shall be allowed for post parades and warm-ups. A minimum of ten minutes shall elapse between the time the horses enter the track and arrive at the starting gate. Riders must be mounted for post parade.
19. No horse shall be permitted to start in the Illinois-bred races unless the Illinois Certified Jockey Club Certificate is on file with the Racing Secretary.
20. No horse is qualified to run in any race unless he is duly entered in that race.
21. In the case that a State Investigator is not present at the fair during the races, the Racing Secretary, or his authorized representative, will identify each horse entered by comparing markings and/or the tattoo listed on each horse's Jockey Club registration certificate before racing.

THOROUGHBRED SECTION

I.C.F.T.A. AWARDS

LEADING MONEY EARNERS

The Illinois County Fair Thoroughbred Association will sponsor an award to the top money earner in each age category of Illinois Conceived and Foaled races conducted at County Fairs which are members of the I.C.F.T.A. The awards will be presented at the organizational meeting in Springfield in January.

LEADING JOCKEY

Jockey awards sponsored by the I.C.F.T.A. will be awarded to the first and second place jockeys. Determination of these awards will be based upon total points earned in Illinois Conceived and Foaled races throughout the 2012 season. A rider's official order of finish will determine points earned in each Illinois Conceived and Foaled race with 5 points for 1st place, 4 for 2nd, 3 for 3rd and 2 for 4th.

OLD NATIONAL ROAD DERBY

The listed fairs that will be sponsoring this event will provide \$1,200.00 additional for the horse that wins all three legs, if a horse should win two legs the owner will receive \$600.00.

As a courtesy to the IL Running Quarter Horse Assoc. (IRQHA) the following information is offered.

ILLINOIS QUARTER HORSE REGULATIONS

1. An administrative/maintenance fee is collected on Illinois-bred state paid purses.
2. Illinois-bred 3 yr. olds & up races must have three (3) entries to start with three (3) different owners to start or the races are not conducted. Any horse that is scratched, which would cause the race not to run, will not get their administrative fee returned, but the rest of them will.
3. If a horse is entered and programmed, then is scratched, the administrative fee is not returned. If the race or races are cancelled due to weather before or after the race has started, the fairs will retain \$10.00 of the fee and the remaining \$15.00 will be returned to the owner of the horse.
4. The Racing Secretary of the fair association will be authorized to receive entries and declarations.
5. All entries must be made in writing on Official Entry blanks furnished by the fair association and all requested information must be furnished at the time of entry. Entries may be made by telephone, if promptly confirmed by the racing Secretary and will be valid or recognized, if the name of the horse has been printed on the "Official" program.
6. All entries will be closed at advertised times.
7. At the closing time for filing entries for the succeeding day, the horses entered shall be drawn by lots for the post positions and a typewritten list of horses drawn will immediately be posted on the bulletin board in the Racing Secretary's office for inspection by the owners and trainers.
8. All horses must be stabled on the fairgrounds no later than two (2) hours prior to the post time for the first race of the day.
9. Jockeys must wear protective helmets and vests.
10. Jockeys must be attired in racing silks.
11. No jockey shall be permitted to ride who is presently suspended or ruled off in the State of Illinois or in any other state.
12. A mechanical starting gate shall be used at the start of all races and a horse shall not be considered a starter unless he leaves the starting gate with the field.
13. No horse shall be permitted to start in the Illinois-bred races unless the Illinois Certified Registered Quarter Horse papers and AQHA papers are on file with the Racing Secretary and all starting fees paid.
14. AQHA registration papers and IL eligibility certificates will be checked by the state investigator at the draw-gate or before entry on to the track. In the case that a state investigator is not present at the fair during the races, the Racing Secretary, or his authorized representative, will check these items.
15. Purses will be divided as follows: 50%-25%-15% & 10%.

Section 290.215 Illinois Conceived and Foaled Thoroughbred Races; County Fairs

TITLE 8: AGRICULTURE AND ANIMALS CHAPTER I: DEPARTMENT OF AGRICULTURE SUBCHAPTER I: HORSE RACING AND BREEDING

PART 290

THOROUGHBRED HORSE BREEDING AND RACING PROGRAMS, ILLINOIS

Illinois Thoroughbred Breeders Fund Program:

- a) The Illinois Horse Racing Act of 1975 provides \$75,000 annually for purses to be distributed to county fairs that provide for the running of races during each county fair. These races will be open to thoroughbreds that are properly registered as Illinois Conceived and Foaled with the Department.
- b) The conditions of the races shall be developed by the county fair association and reviewed by the Department, with the advice and assistance of the Illinois Thoroughbred Breeders Fund Advisory Board.
- c) County fair associations desiring to participate in this program shall file an application for participation with the Department on or before February 15th each year. Applications are available from the Department. Information as to location, date, track surface and number of permanent horse stalls available must be given.
- d) The Department may at any time order the cancellation of a race or races if funds have been conditionally allocated to a fair association and the conditions have not been fulfilled prior to opening day of the fair. Any violation of this Subpart shall be just cause for denying distribution of fund monies to the county fair and/or the money winning horse owners.
- e) The purse distribution shall be as follows: 50% to the winner; 25% to second; 15% to third and 10% to fourth.
- f) The president and secretary, or his/her authorized representative, of each county fair association claiming the benefit of any distribution from the Illinois Thoroughbred Breeders Fund shall file with the Department, within 7 days after the last racing day of a county fair, 2 official programs, an affidavit stating that this Subpart has been complied with, including

the amount of purses put up by the county fair, the names and addresses of those owners who are to share in the total purse and the amount in which they are to share.

- g) The fair association shall appoint a Racing Secretary, 3 placing judges, starter and a timer as the officials to conduct the races.

These officials shall be appointed at least 2 days prior to the date of the races. The list of those appointed officials must be submitted to the Department no later than 24 hours before the running of the races.

- h) The Department investigator may identify each horse starting in a race by means of description on the Jockey Club Certificate and verify Illinois conceived and foaled registration.
- i) It shall be the duty of the 3 judges to conduct the races and their decision shall be final in all matters pertaining to the running of the races, including the finishing order of horses. All questions pertaining directly to racing arising during the program of races at county fairs shall be determined by the judges.
- j) It shall be the duty of the Racing Secretary to ascertain that the owner of a horse in whose name said horse is entered is the last owner of record on the Jockey Club Certificate.
- k) The Racing Secretary shall record the Illinois conceived and foaled registration number of each Illinois conceived and foaled horse competing in the races and furnish this information to the Department.
- l) No horse shall be eligible to be entered in a race that is receiving money from the Illinois Thoroughbred Breeders Fund unless the horse has been duly registered as an Illinois conceived and foaled thoroughbred. The Illinois registration number shall be recorded on the entry blank at the time an entry for a race is submitted to the Racing Secretary.
- m) In the event that the number of entries to any race is in excess of the number of horses that may, because of track limitations, be permitted to start, the starters for the race shall be determined by lot in the presence of those making entries, and the post position shall be in the order in which the starters are drawn. The same method shall be used in determining the starters and post positions in case any race is divided or split.

Section 290.270 Quarter Horse Racing at County Fairs and Other Locations

TITLE 8: AGRICULTURE AND ANIMALS CHAPTER I: DEPARTMENT OF AGRICULTURE SUBCHAPTER I: HORSE RACING AND BREEDING

PART 290 QUARTER HORSE BREEDING AND RACING PROGRAMS, ILLINOIS

Illinois Quarter Horse Breeders Fund Program:

- a) A county fair or other location, upon approval of the Department, may conduct quarter horse races for Illinois conceived and foaled quarter horses in compliance with the conditions established in this Section.
- b) The president and secretary, or his/her authorized representative, of the racing event claiming benefits of any distribution from the Illinois Racing Quarter Horse Breeders Fund shall file with the Department, within 7 days after the last racing day, a document stating the amount of purses contributed by the county fair or other location, the names and addresses of those owners who received Illinois Racing Quarter horse Breeders Fund purse money and the amount each horse owner received.
- c) All races that receive funds from the Illinois Racing Quarter Horse Breeders Fund must be conducted in accordance with the rules of the American Quarter Horse Association.
